

# Work Visa options for employees in the sport and recreation sector

**Option** Requirements Result Visa may be valid for 6-23 months. ▶ Fixed term employment agreement (permanent employment No specific employer Working holiday agreement not permitted) The length of work permitted in total within ▶ Primary intention must be to holiday the validity of the visa varies Visa permits the holder to work for any ▶ Must be living together with a work visa holder, New Zealand **Partnership** employer, anywhere in New Zealand citizen or resident, in a genuine and stable relationship ▶ Not dependent on a job offer, just relationship Valid for up to 24 months The visa options most likely to be utilized A work visa valid for up to 5 years (generally ► Fixed or permanent employment agreement term **Essential Skills** ▶ Immigration New Zealand must be satisfied that there are no 3 years) suitably qualified New Zealand citizens (or residence class Specific to a particular job, employer and visa holders) available to do the work (Refer to separate guidelines) location ► Market salary required Maximum duration of 3 years for coaches Specific Purpose or ▶ Individuals in New Zealand for a specific purpose or event and 12 months for sports players. ► Applicants must be adequately remunerated **Event** Specific to a particular job, employer and ► Local permanent employment agreement not permitted location Visa valid for 30 months ▶ Permanent offer of employment Pathway to New Zealand residence. Talent Visa ► Salary and age restrictions apply Specific to a particular job, employer and ► Supporting employer must be an Accredited Employer location
