# **SportNZ Transgender Guiding Principles**

Thank you for the work that you have done to date on reviewing the Transgender Guiding Principles.

I have had a chance to review and consider the updated draft guiding principles, and shared them with my colleagues for their feedback.

As you know, the National-NZ First coalition agreement commits to "ensure that publicly funded sporting bodies support fair competition that is not compromised by rules related to gender".

Having reviewed the draft guiding principles and considered feedback from my colleagues, I have come to the view that in order to deliver on the coalition agreement, SportNZ should no longer have guiding principles published and should leave that decision making and judgement up to individual sports and community organisations.

As you know, one of my priorities for the Sport and Recreation portfolio is lifting participation. The Government has a role in making sport accessible to all New Zealanders by creating opportunities, not in providing principles as to who should be included and how.

I ask that you reply to me with how you intend to give effect to this, and work with my office on public communications.
